CORPORATE MEMBERSHIP

The Corporate Golf Membership is an Annual Membership Contract that automatically renews on the joining date the following year. Corporate Golf memberships are for businesses that are organized legal entities, actively engaged in a trade or business. The corporation must appoint a person or persons that will have the authority to decide the status and direction of this membership, along with determining the users under the provisions set forth. Full Family Golf membership categories are the only memberships that apply to the Corporate Membership plan. The appointed authority to this corporate membership may change designated users each year without any additional charges. Designated users must be owners, officers, employees or directors of the corporation. Corporations may choose not to renew the Annual contract by submitting a resignation notice 30 days prior to the renewal date.

- Designees are given the option of registering for the Annual Cart Lease program
- Charge privileges with individual statements
- Accompanied guests privileges
- Seven day advance starting times at Sugarmill Woods and Southern Woods

Rules of the Annual Corporate Membership

- The membership must be held in the name of a corporation, partnership, company or business entity
- LLC or Tax I.D. # required
- The Corporation must submit a \$500 refundable deposit
- Each Designee must submit a Membership Application form
- The membership will be issued to the entity and the entity will be liable for all unpaid charges of the Designees.
- Designees may be changed with written authorization from the entity, along with a completed Application of Membership.

MONTHLY GOLF PACKAGES

THE “MONTHLY” GOLF PACKAGE Permits the use of all facilities of the Sugarmill Woods Country Club, Southern Woods Golf Club & World Woods Golf Club. Membership is available to all those who reside in the Sugarmill Woods or Southern Woods Community.

The seasonal Golf Package is available on a monthly basis, **not to exceed any three months** during a rolling twelve month Period. Package fees include all dues, golf and cart fees, and unlimited range balls. Packages are collected in advance, and are non-refundable. All other charges are paid at the time of service via credit card. (Accepted credit cards will be determined at the discretion of management). Based upon availability certain events may restrict advance tee times and entrance into special events.

THE TENANT / RENTER MEMBERSHIP

Includes use of Southern Woods Golf Club and/or Sugarmill Woods Country Club, tennis, pool, racquetball, and shuffleboard at the Oak Village Sports Complex for the entire family, i.e.: member, spouse, and all dependent children under 21 years of age for those who reside in Citrus or Hernando County for less than three months during a rolling twelve month period. Green fees are applicable and advance tee time reservations are restricted to two days in advance. Membership privileges are also available for tenants at an additional monthly fee for no longer than a three month period.
